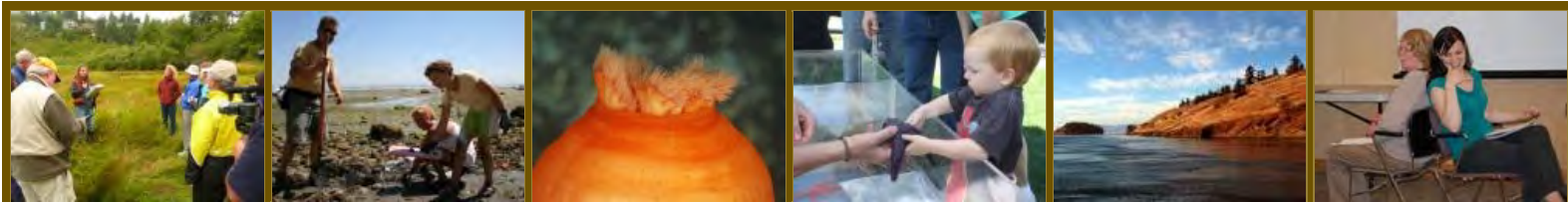

In the News



SNOHOMISH AND ISLAND MRCs UNANIMOUSLY ENDORSE PORT SUSAN MSA

Meeting together in Coupeville on December 6, the Island and Snohomish MRCs voted unanimously to recommend leaders of the two counties adopt the draft plan to establish an educational Port Susan Marine Stewardship Area. The vote culminated five years of discussions, community meetings, workshops, study and planning in a community process to develop a science-based marine stewardship area for this body of water. Additional partners include the Tulalip Tribes, Stillaguamish Tribe, The Nature Conservancy, Washington Sea Grant with the support of the Northwest Straits Commission, and the WSU Extension offices of Island and Snohomish counties. ISLAND COUNTY PROJECTS FUNDED

Congratulations to the Island County MRC and their partners for their success in securing funding for two important [Watershed Protection and Restoration projects](#) on Whidbey Island. The Town of Coupeville will receive nearly \$500,000 for a Penn Cove surface water runoff project, and the Whidbey Island Conservation District will receive \$120,000 for an Ebey's Prairie stormwater remediation project. The Island County MRC is a partner organization on both projects.

WHATCOM COMPLETES CREOSOTE LOG REMOVAL

In a joint effort by the Whatcom MRC, Washington Department of Natural Resources, the Cliffside Community, and the City of Bellingham, the last remaining beach in Whatcom County was cleared of creosote and treated logs in December, 2011. Twelve members of the City's WCC crew hand-hauled 3.35 tons of rogue logs off the beach.

This marks the end of ten years of creosote log cleanup in Whatcom County. The majority of source logs from derelict structures have also been removed in the county, so minimal re-accumulation is expected.



IN MEMORIAM

Two MRCs are mourning the loss of beloved advocates for our marine resources, Dawn Whitehead Lawrence and Jan Holmes. Dawn, a member of the Snohomish MRC, was a devoted educator, coach, and mentor, and her interests centered on the success of her students and athletes. She previously served as chair of the MRC and provided great leadership. Island MRC has also recently lost an important community member. Jan Holmes was a recipient of the 2010 Cox Conserves award, and an active Beach Watcher volunteer on MRC projects. She was a tremendous advocate for our marine resources and environmental education, and she will be greatly missed.

MAYNARD BEACH RESTORATION PROJECT



This month, Jefferson MRC, the North Olympic Salmon Coalition and other project partners are completing the design phase of the Maynard Beach Restoration Project, at the head of Discovery Bay. During the past six months, project partners worked closely with many stakeholders to come up with a design plan that will have great ecological benefits, including improved habitat for migrating juvenile salmon, shellfish and shorebirds. Partners also worked through many challenges to accommodate a trail allowance for public access as part of the Olympic Discovery Trail. Next steps include engineering and construction permitting. Congratulations to Jefferson MRC and NOSC for bringing this project to its nearly shovel-ready state!

FOUNDATION YEAR END FUNDRAISING

The Foundation extends thanks to all the businesses and individuals that contributed to our year-end fundraising efforts. Many local businesses and individuals contributed items to the silent auction at the MRC conference in December, raising over \$5,000 to support MRC projects and activities. Special thanks to Lincoln and Janet Loehr for donating the top earning auction item. In addition, our year-end direct mail appeal raised \$3,525 and ongoing individual donations for the derelict gear matching fund totaled \$6,880. GRANT AWARDS

The Northwest Straits Foundation received \$310,000 from the Salmon Recovery Funding Board for derelict fishing gear removals in San Juan County (WRIA2) and Island County (WRIA6). These funds will pay for the removal of approximately 190 derelict fishing nets from marine habitats in WRIA2 with concentrations at Hein Bank and along the west side of San Juan Island. In WRIA6 approximately 30 fishing nets will be removed from the west and east sides of Whidbey Island, Lawson Reef, and off the south end of Admiralty Head. The Foundation also received \$25,000 from the Lucky Seven Foundation for derelict gear removal.

MRC FUNDING UPDATES

Foundation staff continue to work with MRCs to identify priority projects and potential funding sources, and to develop and submit project grant proposals. Two proposals developed through this process were successful in December. The Washington Department of Fish and Wildlife's Puget Sound Marine and Nearshore Protection and Restoration Grant Program awarded a \$99,000 grant for targeted outreach to county planners and coastal landowners in the Port Susan Marine Stewardship Area, with a goal of reducing the number of applications received for shore hardening permits. The project is collaboration between Snohomish and Island MRCs and their County Planning Departments. A \$10,000 grant was also awarded by the Burning Foundation, for outreach by MRCs related to forage fish. The grant will help support a speaker series, community events and landowner workshops.

CHANGES IN LEADERSHIP ROLES

The Executive Committee of the Northwest Straits Foundation appointed Joan Drinkwin as interim director and Ken Carrasco as interim treasurer at their January meeting. Many thanks to Ginny Broadhurst and Terry Stevens for their past leadership. Ginny will continue to work closely with the Foundation in her role as the director of the Northwest Straits Commission.

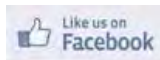

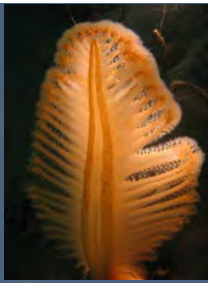

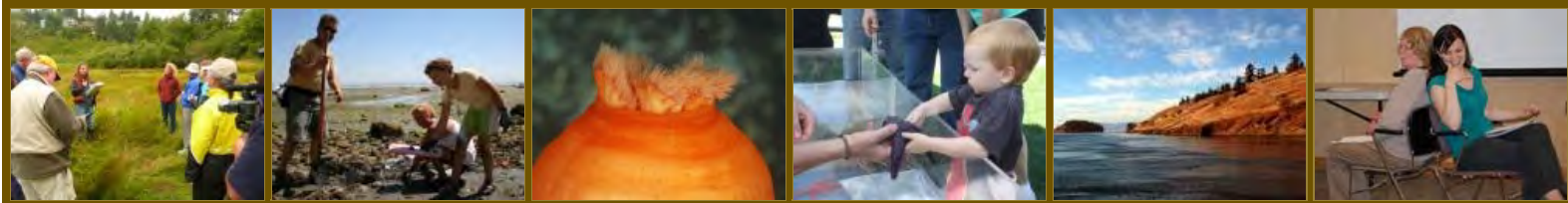

BUDGET UPDATE

The Northwest Straits Commission recently learned that the Puget Sound Partnership will provide capacity funding for the Commission and seven MRCs that will start July 2012 and run through June 2013. This funding will cover operating expenses and support the infrastructure that's needed to for MRCs to continue to serve as their local community advisory on marine issues. The Commission and MRCs, as well as the Northwest Straits Foundation, will continue to pursue opportunities for project funding. "We're happy to be working with the Puget Sound Partnership and greatly appreciate this support." said Ginny Broadhurst, Director of the Northwest Straits Commission.

SOUND WATERS 2012

Well over 500 people, including Island and Snohomish county MRC members, turned out on a sunny Saturday for the 17th Sound Waters conference. Hosted by the [WSU Island County Beach Watchers Program](#), this "One-Day University" has earned a reputation for drawing experts from numerous disciplines, and natural history buffs of all ages and interests. The conference featured a record 63 classes covering coastal geology to dragonflies, with a [terrific keynote presentation](#) delivered by SeaDoc Chief Scientist and Northwest Straits Commissioner Dr. Joseph Gaydos.

MARINE DEBRIS DRAWS CROWD TO CLALLAM MRC

More than 80 people attended the January Clallam MRC meeting in Port Angeles to learn about the marine debris resulting from last year's terrible earthquake and tsunami in Japan. The debris is already showing up on some of Washington's coastal beaches and much more is expected. Nir Barnea, regional director for NOAA's Marine Debris Program, showed aerial photographs and oceanographic models to explain what's currently known about this debris and to encourage preparedness. 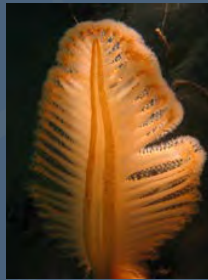

ANNUAL RETREAT A SUCCESS

The Northwest Straits Initiative held its annual two-day retreat on March 1-2 at Padilla Bay in Skagit County. Representatives from all seven MRCs, along with Governor appointees, several MRC staff members, Commission and Foundation staff all participated. Discussion included how to best support the work of MRCs, linkages between local and regional environmental priorities, and coordination between the Northwest Straits Commission and Foundation.

DERELICT VESSEL PROGRAM GETS A BOOST



The San Juan MRC worked with community partners to raise more than \$10,000 as seed money to reinstate the county's Derelict Vessel Program, which was shelved in 2008 due to budget cuts. The County committed to providing at least two years of support, and has contracted Joanruth Baumann, who successfully ran the program when it was housed in the Public Works Department. The Port of Friday Harbor, San Juan Power Squadron, San Juan Island Yacht Club, Common Sense Alliance and several local marinas partnered in this effort, which has been further boosted by a grant from the Puget Sound Partnership, to help identify boats in danger of sinking before they become a problem.

PROPOSED COAL TERMINAL OF INTEREST TO LOCAL MRCs

A proposal to build a new coal terminal at Cherry Point in Whatcom County has sparked the attention of a few MRCs. As proposed, the project would significantly increase the number of trains carrying coal to Cherry Point and would also create an increase in shipping traffic that would serve the terminal. MRC members are asking questions about the potential impacts of train traffic, coal dust and vessel noise, and want to be sure that the required Environmental Impact Statement adequately addresses their questions. HAZWOPER TRAINING

On February 11, the Clallam MRC co-sponsored a Hazardous Waste and Emergency Response (HAZWOPER) class attended by 75 people. Oil spill preparedness is a priority for the MRC, and the training is a prerequisite for oiled wildlife recovery training. Other co-sponsors included the US Coast Guard, Washington Department of Fish and Wildlife, Surfrider, and private contractors.



SKAGIT RESTORATION INITIATIVE FUNDS AWARDED FOR 2012



Two new projects will soon receive funding from the Skagit Restoration Initiative (SRI) in response to a competitive RFP process. SRI funds are administered through the Foundation and are restricted to the implementation of restoration projects or land acquisition that yield ecological benefits to marine, estuarine and anadromous species in Fidalgo and Padilla Bays.

One project will provide funding to the Padilla Bay Reserve in support for the purchase of a 70-acre tidelands parcel, the largest single privately held ownership remaining. Once they are owned and managed by the Reserve, these lands will be protected in perpetuity under a Federal Management Plan for the purposes of resource conservation, research and education.

The other new project will be carried out under contract with the [Puget Sound Restoration Fund \(PSRF\)](#), expanding a native oyster restoration project in Fidalgo Bay. PSRF will work with Skagit MRC, Washington Department of Natural Resources and the Samish and Swinomish Tribes to enhance the native oyster population by increasing settlement structure.

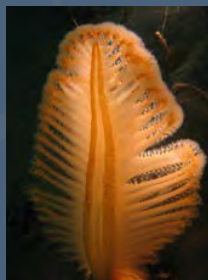

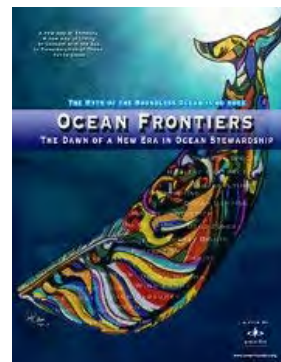

OCEAN ACIDIFICATION SEMINAR

On March 22 the Northwest Straits Initiative hosted an evening seminar on Ocean Acidification featuring Brad Warren of Sustainable Fisheries Partnership and Dr. Terrie Klinger from the University of Washington. Terrie talked about the science of ocean acidification and the implications locally in Puget Sound and Brad shared his enthusiasm for the need to communicate about ocean acidification and taking steps to adapt and mitigate its effects. SAN JUAN MARINE MANAGERS' WORKSHOP

The 2012 Marine Managers' Workshop held on March 26-27 in San Juan County was a huge success with 75 participants - including several from Canada - fascinating presentations, and ample opportunity for networking and collaborating. The focus areas of this year's workshop were *Oil Spill Prevention and Readiness* and *Salmon Recovery Research and Planning in the Shoreline Built Environment*. Participants left with an increased understanding and awareness of the frequency of oil spills in the San Juans, the extensive resources and response strategies in place, and suggestions for engagement for the San Juan marine management community.



A highlight of the workshop was the roll out of the "Pulling it All Together" project, which focused on conducting a science-based analysis of existing conditions in the County in order to to prioritize protection and restoration actions that will support the recovery of wild salmon populations. This project included pocket beach mapping, a refined geomorphic shoreform and stressor geodatabase, a marine riparian inventory, identification of priority salmon recovery regions, identification of top stressors, degradation analysis, a sea level rise risk/resiliency screening tool, and shoreform scale restoration and protection project prioritization.

LITTLE FISH, BIG IMPACT

On April 11, Northwest Straits Commissioner Joe Gaydos and staff member Caroline Gibson were among twenty participants from Washington, Oregon, and California in a meeting on



forage fish protection in the California Current Ecosystem. Central to discussions was the extraordinary importance of forage fishes regionally and worldwide, as demonstrated in the [new report](#) from a national task force that included leading researchers at the University of Washington. Several organizations represented at the meeting are engaged in fisheries policy and management efforts to ensure that herring and other species which are commercially harvested, as well as sand lance and others that are not, will be adequately protected in order to sustain healthy marine ecosystems and coastal economies. It was noted that surveys and monitoring by the MRCs and project partners are engaging local citizens and generating information that is critical to forage fish habitat restoration and protection efforts.

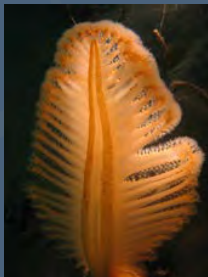

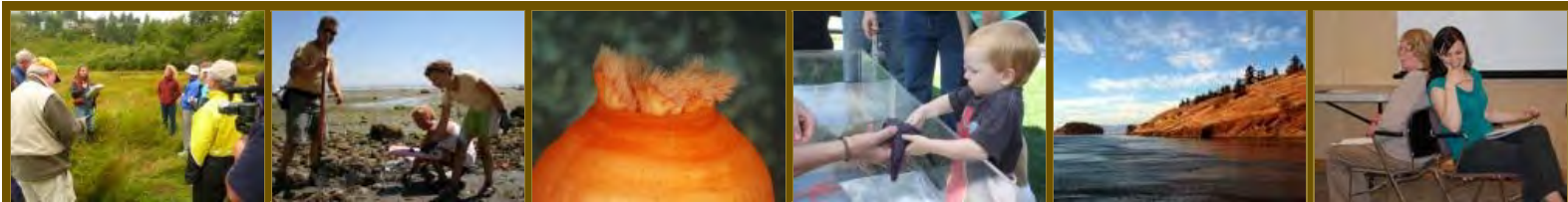

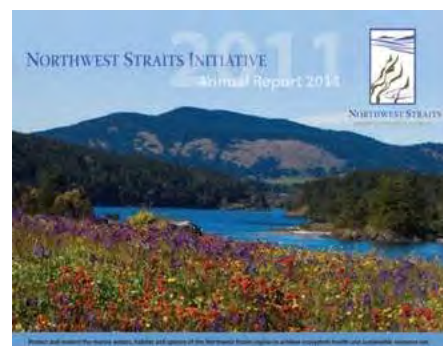

EELGRASS PROTECTION: A LOCAL MODEL OF EFFECTIVE STEWARDSHIP



Jefferson MRC's **Anchor Out for Eelgrass** project enters its 9th year with this month's installation of six marker buoys along the Port Townsend waterfront. The East Jefferson Fire and Rescue Department generously provided a diver, captain, and boat to assist commercial diver and MRC volunteer Amy Leitman in launching the buoys on May 3. The buoys are an effective reminder for recreational boaters to anchor away from eelgrass beds.

The MRC welcomes new support this year from the Sheriff's Department, whose divers shadowed recent operations for potential involvement in the project next year.

DERELICT FISHING GEAR REMOVAL PROGRAM

The derelict fishing gear removal program is back in full swing with two removal vessels working in Island and San Juan counties. The F/V BetSea is operating out of Cornet Bay and removing nets off of Lopez Island. The R/V Surveyor II is operating out of Everett and removing nets from



Island County waters.

Both operations are funded by the Salmon Recovery Funding Board, NOAA Marine Debris Program and the U.S. Fish and Wildlife Service Coastal Program.

PORT SUSAN MARINE STEWARDSHIP AREA

Last week members of the Port Susan Marine Stewardship Area Advisory Team visited The Nature Conservancy's Port Susan Bay Preserve. Kat Morgan of the Nature Conservancy led the field trip along the dike that will be breached this summer to restore 150 acres of former tidal marsh. CORNET BAY RESTORATION

In Island County the MRC has been working for several years on a shoreline restoration project in Cornet Bay, a project that has successfully leveraged other grant funding and volunteers.

The project is a multi-partner shoreline restoration with principle grants managed by the Northwest Straits Foundation. WSU Beach Watcher volunteers are in their fourth year of counting critical ESA listed Chinook and other fish at the beach with just a small amount of Island MRC funding. This work generates data analysis and reporting writing that is funded and managed by Island MRC, and made available to the public and the scientific community on the Island MRC web site. 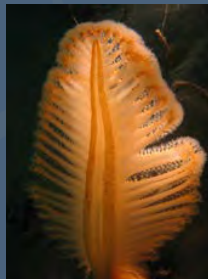

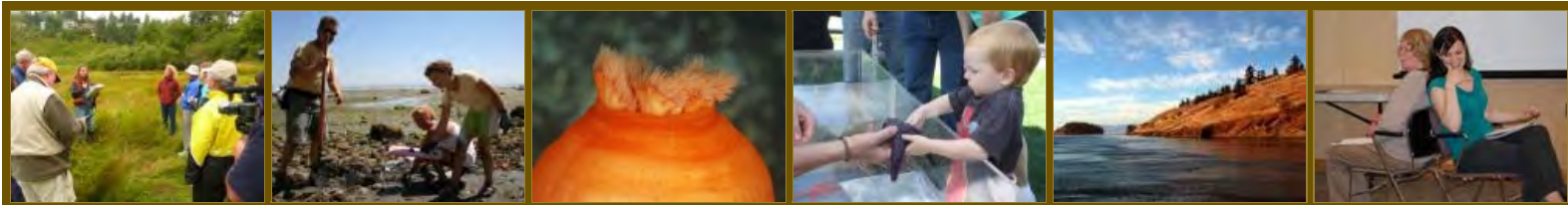

In The News

COMMUNITY BEACH SEINING



Skagit MRC, in partnership with WWU's Shannon Point Marine Center and WSU Beach Watchers, sponsored a community beach seining day on June 14 at Ship Harbor in Anacortes. About 50 people participated, including students from Anacortes High School and local community members. This event increases public awareness of the marine environment and creatures that live in our local waters.

Most notable in the catches were several hundred juvenile pink salmon, surf smelt large and small, a few juvenile sand lance and several larval rockfish. After counting and identifying each species, all were returned to the water alive. Another seining is scheduled for mid-August. Check our web site for more information as the date approaches.

WHATCOM SHORELINE LANDOWNER WORKSHOP



The Whatcom MRC continued its successful Coastal Landowner Outreach project from 2011 with a workshop focused on using native vegetation for slope stability. Seventeen people from the Lummi Peninsula, Point Roberts, Birch Bay, and Drayton Harbor attended the half day workshop which included a low-tide walk at Point Whitehorn.

During the classroom session, bluff processes, planting for slope stability, and regulations/permitting related to bluff management and planting were covered. Coastal geology expert Jim Johannessen led the field trip portion of the workshop and showed examples of proper bluff management as well as places where management could be improved.

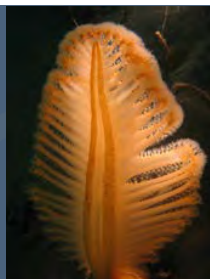

CLALLAM MRC OILED WILDLIFE TRAINING

Clallam MRC recently sponsored two classes to train volunteers to capture and stabilize oiled wildlife in the event of an oil spill. The first class emphasized stabilizing oiled birds. Students learned about facility layout, basic bird anatomy, how to recognize signs of stress in the bird, and how to handle the birds for data collection and stabilization. Students participated in hands-on practice with live birds.

In the second class, students reviewed anatomy, handling, and intubation, and learned techniques for bird capture in the field. The timely arrival of wind and rain assured a 'real life' scenario as students searched for and captured birds on Ediz Hook!



SOUNDIQ - PHASE II

Island MRC, in coordination with the City of Bellingham and Padilla Bay GIS Analyst Suzanne Shull, recently completed phase two of the SoundIQ web mapping application. The newly-updated application now includes feeds from eight external data sources, including weather feeds, FEMA flood zones, and tsunami inundation areas. OCEAN FRONTIERS SCREENING

Snohomish MRC recently partnered with the City of Everett to host a screening of the ocean stewardship film, *Ocean Frontiers*, at the Everett Performing Arts Center. A panel discussion with local and regional experts on ocean stewardship followed the film. Panelists included Kit Rawson of the Tulalip Tribes, Graham Anderson of the Port of Everett, and Andrea Copping of the Pacific Northwest National Laboratory and former Northwest Straits Commissioner. Attendees shared positive feedback, including the value of collaboration over confrontation, hope, and the goal to become more engaged in efforts to protect our local waters.

MUSSEL WATCH EXPANSION

Snohomish MRC involvement in sampling live mussels for contaminants in the nearshore was showcased in a recent series of Mussel Watch workshops by the Washington Department of Fish and Wildlife. The agency is seeking volunteers to help with a pilot project encompassing 60 sites, in Bellingham and Whidbey Basins, and Central and Southern Puget Sound. Northwest Straits Commission Highlights

The June 29 meeting of the Northwest Straits Commission was held at the Jamestown S'Klallam Tribal Center in Blyn, Clallam County. State Representative Steve Tharinger provided a welcome.

Shannon Davis of the Jefferson MRC gave an update on their Port Townsend Voluntary Eelgrass Zone project, and showed a short video about their work to create a Harbor Management Plan to protect Mystery Bay shellfish harvest.

In 2011 Northwest Straits Commission received Washington Shellfish Initiative funding for native Olympia oyster restoration. Chris Kaplan, shellfish biologist from the Jamestown S'Klallam Tribe gave an update on the Tribes' role in that project. Tribal tidelands in Sequim Bay have been identified for planting oyster seed this summer.

The Commission unanimously agreed to submit comment to federal agencies, requesting the preparation of a programmatic environmental impact statement on the proposed coal transport facility at Cherry Point, in Whatcom County. [Click here to view the letter.](#)



Jenna Jewett from WA Department of Fish and Wildlife provided an update on the work of the coastal MRCs. Tsunami debris was identified as a common interest among coastal and Northwest Straits MRCs.

Northwest Straits Foundation Update

DERELICT FISHING GEAR FUNDING RECEIVED

The Northwest Straits Foundation received \$660,000 to finish the job of removing derelict fishing nets from shallow subtidal waters of Puget Sound. The Foundation estimates there are 500 shallow water derelict nets left to remove. The Foundation is aiming to complete the work by December 31, 2013. Funding comes from the US Environmental Protection Agency through the Washington Department of Fish and Wildlife. This funding will be combined with current and pledged funding from the Salmon Recovery Funding Board, NOAA Marine Debris Program, ConocoPhillips Migratory Bird Fund, US Fish and Wildlife Service Coastal Program, Lucky Seven Foundation, Tulalip Tribes and private donations.

The new funding also pays for a new response and retrieval program designed to prevent future re-accumulations of derelict nets by responding to reports of newly lost nets immediately. The Foundation will be developing this new program in close coordination with the Puget Sound fisheries co-managers.

SHANNON POINT NEARSHORE RESTORATION FUNDED

The Northwest Straits Foundation received funding from the US Fish and Wildlife Service Coastal Program to support the Skagit Marine Resources Committee's Shannon Point nearshore restoration project. The project will remove rock riprap from a shoreline at Shannon Point. Funding will move the project forward with feasibility, design, and permitting.



PADILLA BAY TIDELANDS PURCHASED

Seventy acres of tidelands will be added to the Padilla Bay Estuarine Research Reserve and protected in-perpetuity thanks to a grant from the Foundation's Skagit Restoration Initiative, a funding program directed at protecting the marine resources of Padilla Bay and Fidalgo Bay. The Washington State Department of Ecology recently completed the acquisition on behalf of the Reserve. The funding is overseen by the Skagit County Marine Resources Committee.

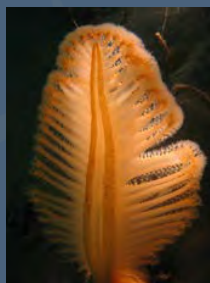

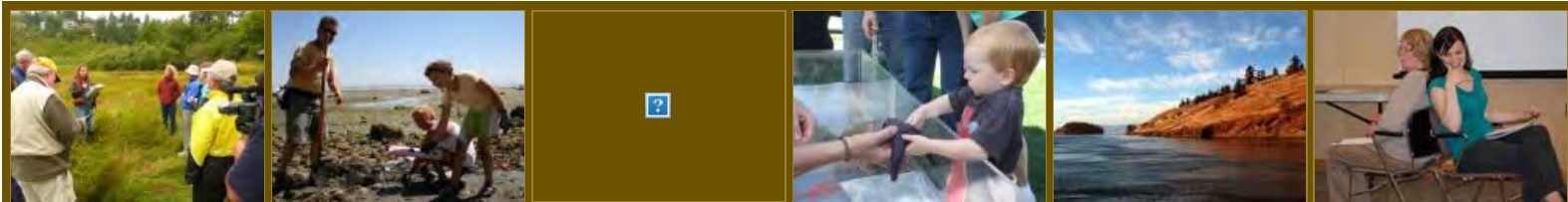

COMMUNITY BEACH SEINING



The Skagit MRC recently held their second community beach seining day of 2012 on August 13, in partnership with Shannon Point Marine Center and WSU Beach Watchers. Project lead Dr. Paul Dinnel reported that more than 60 community members participated in the event, held at Ship Harbor in Anacortes.

Volunteers count and identify each species before returning them to the water alive. This event increases public awareness of the marine environment and creatures that live in our local waters.

LUMMI BEACH CLEANUP AND COMMUNITY OUTREACH

Wrapping up a project that began last year, Lummi Nation recently completed a beach cleanup and community outreach effort supported in part by the Northwest Straits Commission. During the course of the project, more than 40 volunteers, including high school and Northwest Indian College students, participated in four community cleanup events held on local beaches and the Nooksack River delta. Work completed also included removal of derelict fishing gear from the Nooksack River, with help from the Lummi Dislocated Fishers Program.

NORTHWEST COMMISSION MEETING HIGHLIGHTS

At the July 27 meeting in Everett, Snohomish County Councilmember Dave Gossett welcomed the group and expressed his appreciation for the work of the Commission and Snohomish MRC, emphasizing the value of the over 10,000 volunteer hours contributed in support of MRC projects last year.

Lincoln Loehr, a member of the Snohomish MRC and alternate representative to the Commission, gave an overview of the MRC's Mussel Watch program, a subset of NOAA's national long-term water quality monitoring program that is run by the MRC and uses mussels to determine toxics in the water. A copy of his presentation is [available online](#).

Jim West from the WA Dept. of Fish and Wildlife provided information about a pilot expansion of the agency's Mussel Watch project to include 60 sites in Puget Sound. He noted that many partnering organizations and volunteers are ready to collect the samples, and that opportunities exist for MRCs to provide support for additional sampling sites. Terrie Klinger provided an update regarding the Blue Ribbon Panel on Ocean Acidification. The science subgroup has prepared a white paper summarizing ocean acidification in state waters, and is now drafting recommendations. [The presentations from the panel meetings are available online.](#) The panel is focusing on four areas for its recommendations: research and monitoring; quantifying local source contributions; adaptations and remediation; and public education and outreach.

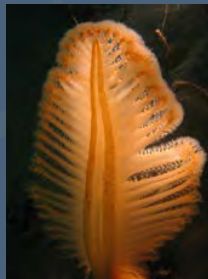

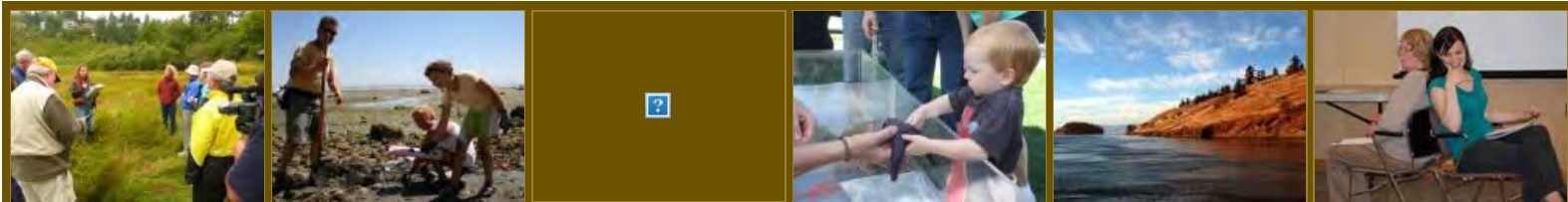

FORAGE FISH SYMPOSIUM

Sixty scientific and policy experts working on forage fish along the West Coast of Canada and the U.S., Alaska, and Great Lakes region convened in a 2-day symposium at Friday Harbor Laboratories organized by the Northwest Straits Initiative.

CORNET BAY RESTORATION UPDATE



The Cornet Bay Nearshore Restoration Project started August 31, with a goal to finish by October 15. Through a competitive bidding process, Matia Contractors from Ferndale was selected to do the construction, which consists of removing the creosoted bulkhead in three sections, with beach grading and nourishment happening in each section before the next section is worked. Come out and see the restored beach emerge!

PORT SUSAN MSA OUTREACH PROJECT UNDERWAY

With grant funding from the Washington Department of Fish & Wildlife's Marine and Nearshore program, the Northwest Straits Foundation is partnering with the Snohomish and Island MRCs to implement a series of outreach activities to reduce shoreline hardening in the Port Susan Marine Stewardship Area (MSA). Activities include the generation of GIS maps showing coastal processes and marine resources in the MSA, needs assessments of shoreline planners and coastal landowners, educational workshops in the MSA for planners and landowners, and an incentives program.



On September 13, the [Coastal Training Program](#) coordinated a *Coastal Processes, Impacts and Alternatives to Shoreline Hardening* in the Port Susan MSA workshop, led by shoreline geologist and coastal processes expert Jim Johannessen of Coastal Geologic Services. The classroom and field sessions provided an opportunity for 23 planners from Island and Snohomish counties to learn about shoreline management issues, specifically the extent and impacts of shoreline stabilization and current approaches to alternative erosion control and beach restoration.

A workshop for marine shoreline landowners will take place on October 13. Following the workshop, shoreline landowners in the Port Susan MSA can receive free site visits from qualified professionals who will provide property-specific shoreline management recommendations. DERELICT FISHING GEAR REMOVAL

Three derelict fishing gear removal vessels are mobilized again to remove the last of the known shallow water derelict nets by December 2013. The F/V Bet-Sea just finished removing nets from piling stubs at Jefferson Head in anticipation of Washington Department



of Natural Resources removing the pilings themselves in October. These piling stubs have snagged literally hundreds of fishing nets over the years, costing fishermen thousands of dollars and killing countless marine animals. We are proud of this collaborative, public-private partnership that is successfully eliminating these underwater hazards.

JEFFERSON MRC'S MYSTERY BAY MANAGEMENT PLAN WINS NATIONAL AWARD

The Mystery Bay Management Plan received the national Waterways Management Award from the National Association of State Boating Law Administrators (NASBLA). The award was presented on September 10 in Mobile, Alabama at the NASBLA national conference. Wade Alonzo, Boating Law Administrator with the Washington Parks & Recreation Commission, nominated the team of state and local officials, community members, tribes and others who developed the Mystery Bay Management Plan for the award.

WEAVERLING SPIT RESTORATION BEGINS

Construction started at Weaverling Spit in Fidalgo Bay on September 4. The project will halt shoreline erosion of a beach and archeological site and enhance forage fish spawning habitat along 500 feet of shoreline. The Samish Indian Nation is implementing the project with a grant from the Skagit Restoration Initiative, a funding program managed by the Skagit Marine Resources Committee and administered by the Northwest Straits Foundation.

NORTHWEST STRAITS COMMISSION MEETING HIGHLIGHTS

State Representative Norma Smith from the 10th legislative district opened the Commission meeting at Padilla Bay Reserve on August 28. Representative Smith was Special Assistant to Congressman Jack Metcalf in the 1990s when the Northwest Straits Initiative was launched. The Commission discussed with Representative Smith the community-driven, bottom-up approach that was envisioned when the Northwest Straits Initiative was created through a bi-partisan partnership between Senator Patty Murray and Representative Metcalf.

Representative Smith is now a member of the state's Ocean Acidification Blue Ribbon Panel (Panel) and encouraged everyone to view the Panel's materials available on the [Department of Ecology's web site](#). The Panel expects to deliver its final recommendations to the Governor in October, along with a public outreach communication plan that is expected to emphasize use of local resources such as MRCs and extension offices to spread factual, scientific information separate from the global warming issue.

The [minutes from the July 27, 2012](#) Commission meeting were approved and are now available online.

The Commission continued discussions about the draft Northwest Straits Initiative Sustainability Plan and the next steps for the MRCs, the Commission and staff. Commission director Ginny Broadhurst will visit each MRC during September to continue conversations about diversifying funding sources and implementing actions to strengthen support.

The next Commission meeting will take place November 2 at 9:30am in Port Townsend, prior to the start of the MRC conference. The previously scheduled September 28 meeting was canceled.

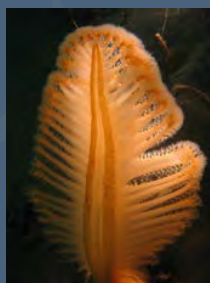

LANDOWNERS IN PORT SUSAN ATTEND *LIVING WITH THE COAST* WORKSHOP

Over 60 marine shoreline landowners from Island and Port Susan landowner workshop Snohomish Counties attended an October workshop on Camano Island to learn about issues impacting the Puget Sound nearshore, shoreline processes and management alternatives. The Northwest Straits Foundation sponsored the workshop through a grant from the Washington Department of Fish and Wildlife and conducted the event in partnership with the Island and Snohomish Marine Resources Committees. During the workshop, Jim Johannessen and Stephanie Williams of Coastal Geologic Services led the a classroom presentation and beach walk. Landowners in the Port Susan Marine Stewardship Area (MSA) enthusiastically learned that, through this project, they are eligible to receive a free site visit to gain management recommendations specific to their properties. The goal of the project is to reduce shoreline armoring in the MSA by providing landowners with education and incentives to learn about impacts and alternatives to traditional shore hardening. FOUNDATION RECEIVES FUNDING FOR JEFFERSON MRC EELGRASS PROTECTION PROJECT

The Northwest Straits Foundation received \$6,000 from the National Fish and Wildlife Foundation's Fish Habitat Partnership grant program. This funding will support the continuation of voluntary eelgrass protection along the Port Townsend waterfront by placing marker buoys that delineate the no anchor-zone, combined with interpretive signs and brochures. The project has had measurable success in preventing boaters from anchoring in critical eelgrass habitat. Eelgrass is a valued marine resource because it provides critical habitat for commercially-, recreationally- and ecologically-important species including salmon, Brandt geese, crab and herring, and it helps reduce shoreline erosion by absorbing wave energy. The state has a "no net loss" policy to help protect this priority habitat. Congratulations to the Jefferson MRC!

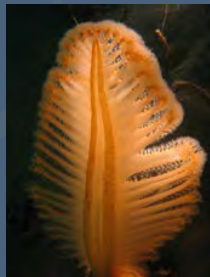

CORNET BAY CONSTRUCTION COMPLETED



Construction at Cornet Bay in Deception Pass State park concluded in October. The construction phase of the restoration project included removing 750 feet of creosote bulkhead and associated fill and re-grading the beach to restore natural elevations. Beach gravel suitable for forage fish spawning was placed in the intertidal zone.



Planting of the upland forest fringe area will occur in late November, followed in spring with planting in the lower elevations. An interpretive sign is being developed and project partners are conducting post-project monitoring of forage fish spawning and fish use of the nearshore. WSU Beach Watchers are contributing time to monitor the site. The Cornet Bay project is a close collaboration between the Northwest Straits Foundation, the Island Marine Resources Committee, the Whidbey Island Conservation District and Washington State Parks.

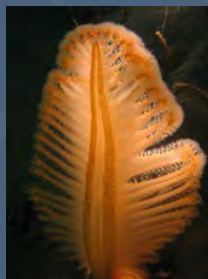

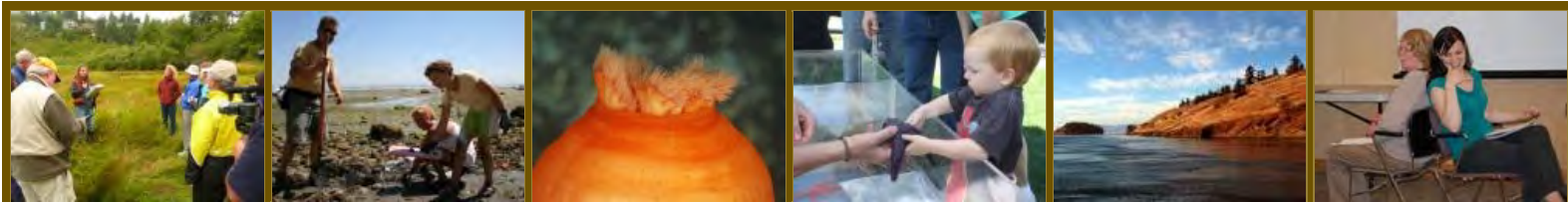

WASHINGTON LEADING THE NATION IN EFFORTS TO ADDRESS OCEAN ACIDIFICATION

On November 27 at the Seattle Aquarium, Governor Gregoire signed [Executive Order 12-07](#), Washington's Response to Ocean Acidification. With this major step and concurrent release of the Governor's [Blue Ribbon Panel report](#), Washington state has taken the first such initiative in the nation on this complex issue. Northwest Straits Commission Director Ginny Broadhurst and members of several MRCs attended the ceremony to hear firsthand the recommendations for meaningful action in this region.

Since 2008, the Northwest Straits Initiative has engaged in regional education efforts around this issue, and is already working on small-scale projects that address ocean acidification locally. CORNET BAY RESTORATION PROGRESS CONTINUES



In November, 20 volunteers coordinated by the Skagit Fisheries Enhancement Group installed over 500 plants in the upland area adjacent to Cornet Bay's newly restored beach and intertidal zone. NORTHWEST STRAITS COMMISSION PROMOTING METADATA STANDARDS

Data collection is a critical component of Northwest Straits Initiative projects to survey eelgrass, forage fish spawning, pigeon guillemots, and more. The details of these data (who collected them, where they were collected, how, when, etc..) are known as 'metadata'. The Commission is currently working on a federal grant from the U.S. Geological Survey's [NSDI Cooperative Agreement Program](#) to create metadata, and transition that metadata to a new [International Standards Organization](#) format, using existing nearshore data on [SoundIQ](#). The report resulting from this project will document - for MRCs, natural resources agencies, and other organizations - the transition strategy, its successes and its challenges.

ANOTHER YEAR OF SUCCESSFUL DERELICT FISHING GEAR REMOVAL!

The Northwest Straits Foundation is pleased to report that, as of November 30, contractors have removed 4,354 derelict nets from shallow waters of Puget Sound. Throughout 2012 the Foundation has managed two removal vessels focusing work at Point Roberts, around Whidbey Island, and in the San Juan Islands. During the second weekend of December, the F/V Tenacious crew pulled its last net for the year at Point Roberts and is taking a well deserved winter break. The Foundation's research estimates that the derelict nets were killing 1,263 mammals, 23,179 birds, 82,659 fish and more than 3 million invertebrates every year. Valuable marine habitats are also negatively affected by these nets. The removal of the derelict nets has restored 616 acres of habitat, mostly low-relief rocky substrate and boulders on sand, mud, or gravel.

A big thank you goes out to all the good folks at Natural Resources Consultants and the captains and crews of the removal

vessels. Their excellent work and high level of productivity are what make the Northwest Straits Initiative's Derelict Fishing Gear Removal program world-renowned.

MRC CONFERENCE EVALUATION

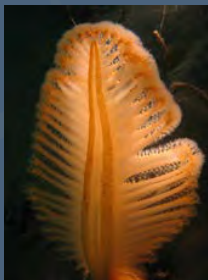
